UPDATE ON THE VOLUNTARY WINDING-UP OF THE COMPANY'S SUBSIDIARY 公司子公司自願清算進度更新

The Board of Directors ("**Board**") of BH Global Corporation Limited (the "**Company**" and together with its subsidiaries, the "**Group**") refers to the Company's announcements dated 24 January 2025, 3 February 2025 and 19 March 2025 (the "**Previous Announcements**").

The Board wishes to provide updates on the progress of OMS' voluntary winding-up, as follows: 董事會謹此提供 OMS 自願清算的最新進度如下:

- (a) As announced by the Company in its Previous Announcements, Mr. Ong Boon Lee and Mr. Jimmy of A Garanzia LLP had been appointed as joint liquidators for the purpose of the creditors' voluntary winding-up of OMS. 如公司於前期公告中所述,A Garanzia LLP 的 Ong Boon Lee 先生及 Jimmy 先生已被委任為 OMS 債權人自願清算的共同清算人。
- (b) The Company wishes to announce that on 5 August 2025, the creditors of OMS had received a letter from A Garanzia LLP on even date notifying them of, and seeking their approval for, the resignation of Mr. Jimmy as one of the joint liquidators of OMS with effect from 15 July 2025. It is noted that Mr. Jimmy had in his letter of resignation confirmed that he has no further claims against OMS in relation to his role as joint liquidator. Accordingly, the creditors have on 6 August 2025 approved his resignation.

- (c) Following Mr. Jimmy's resignation, Mr. Ong Boon Lee will continue to act as the sole liquidator of OMS and will carry out all functions and duties as liquidator relating to the liquidation. 在 Jimmy 先生辭職後, Ong Boon Lee 先生將繼續擔任 OMS 的唯一清算人,並執行與清算有關的所有職責與職能。

The Company will continue to keep shareholders updated and will make further announcements when there are material developments in respect of the winding-up or when appropriate from time to time. 公司將持續為股東提供最新資訊,並於清算事項有重大進展或於適當時候發布進一步公告。
